OUTCOME STATEMENT/TE TAUĀKI Ā-HUA

Strategic Purpose statement/ Te rautaki o te tohu

The purpose of this qualification is to provide the aquaculture, commercial fishing, and seafood processing sectors with people who can work as advanced operators and/or in leadership roles in one or more of their chosen contexts.

Graduates will be capable of working in a self-managed capacity and may have some responsibility for the performance of others.

Graduates will be able to carry out advanced seafood operations in an Aquaculture, Commercial Fishing, General, Resource Management and Compliance or Seafood Processing context to meet the graduate outcomes.

The Te Ao Māori in Seafood strand will allow ākonga/students to build on their qualification in a way that prepares them to lead the application of Te Ao Māori in a kaupapa – led operation.

Graduates of this qualification will be able to:

- Apply quality assurance requirements and advanced technical skills and/or pan-sector industry skills to efficiently complete tasks in a seafood operation/s.

This qualification builds on the New Zealand Certificate in Seafood Operations (Aquaculture/Commercial Fishing/General/Quality Control and Compliance/Seafood Processing) (Level 3) [Ref: 5022].

This qualification leads to the New Zealand Certificate in Seafood (Level 5) with strands in Aquaculture, Seafood Processing and Commercial Fishing [Ref: 3129].

Employment, Cultural, Community Pathway/ Ko ngā huarahi ā-mahi, ā-ahurea, ā-whānau, ā-hapū, ā-iwi, ā-hapori anō hoki

Graduates of this qualification may be employed as operators in aquaculture (working as senior or supervisory technicians or farm staff in daily routine care, husbandry, hatchery, and monitoring fin fish and shellfish), commercial fishing (work as senior or supervisory staff in fish harvesting or post-harvest operations on either deep sea or in-shore vessels), or seafood processing operations on land or at sea (working in senior or supervisory factory roles). Graduates of the Te Ao Māori strand will have the capability to lead the application of Te Ao Māori in a kaupapa-led operation.

To achieve this programme in a Resource Management and Compliance context graduates must be able to carry out quality control tasks in a seafood processing, commercial fishing or aquaculture operation. To achieve this programme in a Seafood Processing context graduates must be able to carry out seafood processing tasks in a seafood operation on land or at sea.
